- TRAINING GROUNDS

Please take note of a temporary condition on the Four Brooks grounds. Last Fall we built a road/dike at the South end of the hay field for the dual purpose of providing a wet weather crossing of a boggy area and collecting water for a pond. The disturbed area, not expected to be flooded, was dormant seeded just before freeze up. This seed should be germinating in the next few weeks. The work will only be a success if we keep heavy traffic off it until it has a season to establish strong turf. I am most concerned about horses and ATV's which are allowed for a trial. The same concern is true for the West area North of Burnt Land Brook that was cleared and farmed for our use last Summer.
